DEPARTMENT HEADS, COMMITTEE REPORTS:

TRUSTEE HOUSTON- Reported:

- Thanked the DPW department for going over and above their duty taking care of the Village.
- Christmas in the Village went very well. Thanked the committee for doing a good job with this
 event. Would like to see the merchants more involved in the future. Mr. and Mrs. Santa were
 well enjoyed.
- Christmas Caroling at the Gazebo went well, about 50 people (many youths). The weather was its usual for this time of the year, cold and wet. The First Congregational United Church of Christ put out refreshments after the event.

• He resigned his position on the Town of Evans Economic Development Committee. The Town will have to appoint another representative of the Village

TRUSTEE KIN – Reported:

- The Angola Library programs are as follows:

- Thanked the DPW for their outstanding job ono the storm clean-up.

TRUSTEE WILSON – Reported:

- Thanked all who participated in the Christmas in the Village. Thanked especially the Fire Department, the fire truck rides are a big hit. Also thanked the Police Chief.
- Thanked the DPW Crew Chief and his crew and his role during the November Storm. Remarked that the clean-up after this snow storm went very well. Thanked the Fire Department and the Evans Police for their great work during the storm as well.
- Discussed his ideas of the Cruise he wants to plan for this year.

TRUSTEE KATRA – Report:

- Thanked the DPW Crew for the good job cleaning out after the storm.
- Congratulated the Evans Police Department for their preparation and work during the storm.

MAYOR FRAWLEY- Reported

- He attended Christmas in the Village and thought the turnout and the whole event was done very well. Also complimented Mr. and Mrs. Santa. Complimented the "letters to soldiers" idea and would like to make more efforts towards the auction baskets for next year.
- Postponed the take down of the decorations due to the weather, hoping to get it completed this Sunday at 8am. Looking for help. Will be working on the mounts.

He and the Clerk took a tour of 59 N Main with representatives from the LANDBANKING group. This will be available for auction. They may look into the international building and the Bundy house or old bowling lanes for future Landbanking sites.

The board shared concerns of the detail of the Landbanking policy and what the Village would be responsible for.

ATTORNEY- Andrew Yusick Reported:

• Finished the demolition of the rear portion of the Old Ford Lanes. Commended Village Engineer Donald Gallo for his expertise on the demolition project, he stayed on top of things that were addressed, and the job went smoothly.

<u>POLICE - Chief Ernest Masullo Reported:</u>

Trustee Houston thanked Chief Masullo for the "global connect" for the residents, so they are called and made aware of current situations.

Chief Masullo:

• commented that the Lake Shore School District started the Global Connect and the Town was able to go on their account. Many people are already receiving calls. This is going to be a big asset for our residents especially when a driving ban and state of emergency is involved. The Town website has information on it. The recent storm, closing of the Thruway, driving ban, all went well with all involved, Global Connect proved to be a big asset to be able to contact everyone on list. Thanked everyone for their help in getting through this storm.

GENERAL CREW CHIEF – Raymond Ashton Excused:

• the Village Board commended the DPW Crew Chief and the DPW crew for their outstanding job during these storm events.

FIRE CHIEF – Douglas Streebel Reported:

- November Storm was challenging but the department got through it. They answered a couple calls and there was a structure fire Sunday night.
- Still working with the ISO representative. Have everything set, except they are missing the training records. The Clerk may have them at the office because they were required by the board.
- Also training for "water on wheels" drill. If we can succeed with this, the area will be called a 5.5 instead of a 5.4
- Total calls for the year were 396. Includes 138 fire and 258 EMS.
- The ladder truck responded for mutual aid twice, one for the Town of Hanover, one for Eisenhower in Derby.
- Been trying to work with the chiefs' council.
- The annual Food drive went well, same day as Christmas in the Village. The Village had the largest food collection than the whole area.
- Received a donated lighted sign from the Eden VFW, will work on having it installed at station #2 in the spring.
- Car Seat, asked the clerk if the cost has been coming out of the grant line, she verified.

FIRE COMMISSIONERS – Absent- the board discussed their absence and the idea of getting new commissioners.

CODE ENFORCEMENT – Charles LaBarbera- Excused

PLANNING - Absent

ZONING – **Absent**

DISASTER COORDINATOR- Warren Jensen- met with the Town, regarding the County DLAN and disaster preparedness.

Mayor Frawley- Erie County looking to combine Evans and Angola and make a central command center.

Chief Masullo- wants to create an emergency operations center. A representative from the Town and Town Fire Departments, and representatives from the Village, all working under one command center.

Mayor Frawley-discussed the warming locations at the schools because they have first aid, and kitchen areas.

Chief Masullo-working with the red-cross, and a trailer equipped with supplies for use in an emergency like this.

Trustee Houston mentioned the Lake Shore High School, back in the 1950's acted as a location for this purpose. The room is still there.

Chief Masullo- they are still thinking of schools as a warming designation.

The board continued to remember the early civil defense years.

Warren Jensen- offered a thanks to Chief Masullo and stated that his efforts saved the Town a lot during this November storm. He did a lot of pre-planning.

Mayor Frawley agreed, and stated that Chief Masullo was handling the PD and the Town Highway Department.

Chief Masullo-had an issue regarding the actions of the county plows, the State came in and plowed county roads.

Discussion continued.

Warren Jensen mentioned the deadline to send the application to FEMA for funding for the November Storm.

CLERK-TREASURER – Linda Giancarlo reported:

- Working on the Budget process as the year comes to an end.
- Closed out December financial reports
- Attended the DLAN training with Warren Jensen. Learned how to use the system.
- Thanked Chief Masullo for his hard work during this event.
- Thanked the Fire Department members, Chief Doug Streebel and 1st Assistant Chief Nick Dybdahl.
- Still trying to figure out the depot grant, there is not enough member item coming in to do a successful complete project.

Trustee Houston mentioned the Railroad Museum and a possible donation for them. The Clerk will contact Caryl Youngers to see if he has any contact information.

• The panic buttons have been installed in the Village Hall and we are still waiting to see if we have been approved for the security cameras.

Trustee Houston asked if the PENFLEX report regarding the members that have not put their beneficiary info in yet have been resolved.

Warren Jensen replied that it has all been taken care of.
